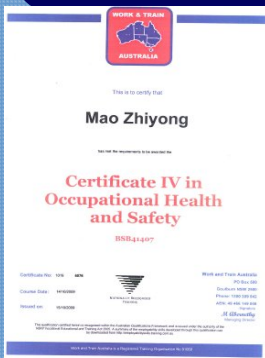
The minimum safety professional requirements for drilling contractors of Saudi Aramco (Drilling and Workover) were amended and ZP Arabia were required to up skill all Safety Officers on Drill Rig sites to meet these requirements. ZP Arabia approached ERSG and its partners to provide the competency based training sighting the fact that the **Certificate IV in OHS out of Australia was the most challenging minimum safety qualification worldwide.** The training was set up to take place over a 3 month period and would include 2 weeks of classroom training and 2½ months of assignments and assessments.

Project Scope

The project scope included a range of Safety and Health training ERSG provided a project plan and schedule for each study that covered the following key areas:

- Training project plan approval-meet Aramco standard
- Provision of both English and Chinese trainers and assessors
- Completion and issue of Certificate IV in OHS-Australian Qualification: BSB41407
- Outcomes based training and assessment
- Presentation skills to be assessed-train the trainer
- Formal Registered Professional Member of the SIA
